#### Message from Chloe-Jane

It was a shame that we did not have the Screen On The Green for Wimbledon this year. Beckenham Together used to arrange this, along with the Christmas Lights and other events.

Beckenham Together was the Business Improvement District (BID) for Beckenham - where BIDs are in place businesses pay an extra levy on their business rates and this funds the BID to undertake Town Centre Management functions the Council used to provide, such as events and other functions that support the businesses. BIDs have to be voted in every 3 years, and Beckenham's BID was not voted back in - it seems that the running of the BID was not aligning with businesses expectations here in Beckenham. Unfortunately as BIDS are limited companies there is less

scrutiny on how the money is spent, unlike when the Council undertook such functions. Beckenham is now left in the predicament of no longer having Council support and not having any additional funding for town events.

I have been working with the Council's Business Team to look at options for Beckenham, but there are no quick and obvious solutions. Beckenham needs a strong town centre business group to work with the Council - if you have a business in the town centre and would like to get involved please get in contact by email to chloe@coperscope.org.uk .

A group of friends and I looked into crowdfunding the screen for Wimbledon, but at £25,000 minimum it was too much of a task for volunteers. I will be working on the Christmas Lights again this year, we need £15,000 for a full display. If you would like to help, please get in touch.

### THE BIG PLASTIC COUNT - GREENPEACE SURVEY




In March, Greenpeace ran a second "Big Plastic Count", whereby volunteers counted their household plastic waste over the course of one week. A creditable 225,000 people took part, recording 4.7m pieces of plastic.

Over 80% was from food and drink, and 9% cleaning and toiletries. Over half of this waste is being incinerated.

There is some good news – around the same number of people counted 6.5m pieces of plastic waste in 2022. So that's down by around a quarter. But this may mean only that the people who took part had had their awareness raised and were avoiding plastic wrappings.

#### Greenpeace is

campaigning for a strong global plastics treaty to cut plastic production by 75% by 2040. There have been some successes so far. The Global Oceans Treaty was agreed in 2023 to protect 30% of our oceans by 2030. The UN has started negotiations on a Global Plastics Treaty.

There has been a noticeable change in some supermarkets packaging from plastic to paper and card. We can help with our shopping choices.

#### CHANGES TO EMERGENCY HELP LINES VIA A LANDLINE

You may have heard adverts recently explaining the landline telephone system is being modernised. Anyone who has a lift alarm/panic button/telecare/pendant or emergency fob that connects via a landline should register with their telephone provider before this happens. They all have a register they call "Priority Services" or "Vulnerable Persons Register". This should be done as soon as possible. Your telephone provider is the company you pay your phone bill to, which may be BT, Sky, Utility Warehouse, the Post Office or others. Registering is often done online. This is for your landline/house phone and not your mobile phone.

The detail is that over time all telephone users will be switched to a digital system. It is not clear when this will happen - it was due to be completed by the end of 2025, but now there are reports that it may go onto 2027. The digital system will rely on power being available at the house, the current

system uses power from the telephone exchange. Unless you have a battery arrangement in the house you will not be able to make phone calls in a power cut, and your telecare pendant, alarm etc. will not connect to the emergency centre either.

Telecare (alarm) providers know already and will almost certainly need to change some of equipment. Some providers are a lot more proactive than others. There is a measure in place to check people don't get switched without having the correct equipment in place first. But this measure is only put in place for those on the register.



Others may just get sent new equipment to self-install, and this is unlikely to work with your existing alarm system.

It is possible that those on the register may be provided with battery back-up. All the utility companies have a similar register and it is worth getting your name on all of them. It won't get you a generator in a power cut or a bowser when the water goes off, but it may eventually get you a knock on the door with a bottle of water and someone checking your welfare.

Chloe-Jane advises that the Council is working with BT on the switch over. When it is Bromley Borough time to switch to digital, there will be a public awareness campaign and also free training sessions - our Associations will be advocating to make sure there are sessions in Beckenham.

#### A memory from wartime Beckenham

To mark the 80<sup>th</sup> anniversary of D Day, here is one of Janet Ambrose's poems about her wartime experiences. Janet is WBRA President and a poet!

A Bomb in Beckenham: An Infant's Perspective by Janet Ambrose, published in "The Ghost at Birkbeck Station and Other Terse Verse" by Austin Macauley Publishers, 2017.

## A bomb in Beckenham (an infant's perspective)

I was two or three On my mother's knee On a bus There was such a fuss

A lady threw herself down on the floor Into the bus's corridor Big sister cried "People are spinning around They fall on the pavement; they fall on the ground And the glass in shop windows is all falling in" "What was it" I wondered, "that caused all this din?"

Mother was shouting (and her voice was a squeal) "The driver, the driver held onto the wheel He held the wheel. He held the wheel Please tell the driver how grateful I feel" The conductor said "Madam, we all do our best And holding the wheel is just one more test"

I was puzzled for many a year to come About "holding the wheel" as screamed out by my mum I understood "wheels" on which buses ran And I knew that the driver up front was a man I was like a spectator with panic all round And I sure he did not jump down to the ground To hold one of the wheels, and why would he do it? Oh, a steering wheel – some years later I knew it.

I was too young to understand what I was hearing Or to know that a wheel in a bus was for steering As I still sat there on my mother's knee Unaware of the near catastrophe Which could so easily have finished us On the Beckenham 227 bus.

Note from Janet – this was probably in 1940, and in Beckenham High Street. I never knew whether the people spinning around and falling were just knocked over by the blast or whether they were killed. They say you don't hear the explosion of the bomb that kills you.... I heard no bang that day.

#### REMEMBERING CLIFF WATKINS



We were greatly saddened to hear that Cliff Watkins passed away in June, aged 85. Cliff was a lovely man – kind and gentle. He was very active in local issues particularly local history and contributed to many events in Beckenham. He co-authored, with Pat Manning, the book "Beckenham. The Home Front 1939-45", using new research and memories of local people from the neighbourhoods of Beckenham, Penge, Anerley and West Wickham.

He was keenly interested in the Blytons - Enid and Carey - who lived in Beckenham. He ran tours of Enid's homes and interests in Beckenham, including one for the Blyton Society, and helped

to get a blue plaque on one the houses. He was also a big fan of David Bowie and it was he who instigated the installation of the orange plaque to Bowie on the Three Tuns pub, where Bowie started off. He ensured the plaque was reinstated when it became Zizzi's restaurant, rescuing it from a skip! He was a member of the West Beckenham RA committee for many years. He will be greatly missed. We send our best wishes and condolences to his family.

#### BANDSTAND AT CROYDON ROAD REC RE-OPENED

On 17 May, both Chloe-Jane and Mike, attended the official opening of the Bandstand on behalf of CCARA and WBRA. It was an enjoyable evening, with lovely food and drinks, and, of course, entertainment on the bandstand. It was a shame the event was not as busy as it could have been the Council could have sold far more tickets.

The Mayor and Mayoress were in attendance and the evening began with an excellent introduction by the Beckenham Concert Band. They were followed by a group of young men from Langley Park Boys school called Nevis, a folk ensemble, Nathaniel Fox Miller, Quinn Murphy and Grimms Back Opera. Councillor Hannah Gray also performed with a fine operatic voice.

Heritage of London Trust (HOLT) had a stall where children and adults alike could gild a wooden crown in 'gold leaf'. HOLT were one of the key supporters in the restoration of the bandstand. They are an independent heritage charity, set up in 1980 by the Greater London Council to rescue historic buildings and monuments. They work in every London borough,

supporting local communities who most need help. You can find out more about them and their work at www.heritageoflondon.org .

The bandstand was built by McCallum and Hope in Glasgow and is thought to be the only surviving example. The refurbishment was partly funded by Heritage of London Trust and by the sale of bricks. Thanks to Friends of Croydon Road Recreation Ground for their long-standing championing of this great project.

We hope to see the bandstand much used by schools, community groups and musicians, and look forward to many more events.



## FAST TRACK REPORTING FOR TFL-RELATED TRANSPORT, STREET AND ROAD PROBLEMS

## SOUTHEASTERN'S VICTORIA RE-SIGNALLING WORKS - LINE CLOSURE 14 JULY

Over several Sundays this year the line between Herne Hill, Brixton and London Victoria will be closed, along with Brixton station and trains will be diverted to and from Blackfriars, Cannon Street and Charing Cross.



## Line closures are planned for:

- Sunday 14 July
- Sunday 8 September

- Sunday 27 October
- Sunday 1 December

During the closures, upgrade work will be carried out by Network Rail (NR) engineers as part of the Victoria re-signalling and station improvement programmes, which will boost reliability, ease congestion, and reduce crowding at the station during peak times. ## Crystal Palace Football Club Academy Copers Cope Road Beckenham BR3 1NZ 23/04907

Permission has been granted to CPFC to install four 21m tall floodlight masts to serve their central outdoor football pitch on Copers Cope Road.

There were a number of objections from local residents concerned about the height and visibility of the lights, their intrusion on neighbouring houses and gardens, potential impact on the local ecology and the effect the extended playing hours might have on traffic and parking along Copers Cope Road.

## 186, 188 & 190 Bromley Road Beckenham BR3 6PG 24/00583

More than 180 letters of objection have been made about a planning application to demolish three neighbouring, detached houses on Bromley Road and replace them with a block of flats. A decision is still awaited from the Council.

The houses are situated on the corner of Ashmere Avenue, near to the Esso petrol station on the brow of the hill. The proposed development is for a four-storey block of 23 flats, with underground car park, comprising 8No 1-bed and 15No 2-bed units providing homes for up to 66 people. 18 car

parking spaces are provided in the basement, accessed from Ashmere Avenue. No affordable housing is provided in the development.

## 114 Bromley Road Beckenham BR3 5NU 23/04630

A second application for the redevelopment of this former residential care home, on the corner of Crescent Road, has been refused planning permission.



The site is currently occupied by a Victorian house, and a large extension built in the mid 1990s. A previous application two years ago to redevelop the land also was refused. The latest proposal involved the retention, part demolition and conversion of the Victorian house and the demolition and replacement of the extension with a new block of flats. The development was for 23 dwellings (one and two-bedroom).

Reasons given for refusal included the lack of up to date information to support the loss of the specialist care home demonstrating that there is no demand for this type of accommodation; the demolition of the original eastern wing of the existing Victorian building would be harmful to the character and appearance of the area; the overall design was considered to be a cramped overdevelopment of the site; and the height, overbearing scale and close proximity to neighbouring boundaries, would have a serious and adverse effect on local residents.

### 76a & 76b The Avenue, Beckenham BR3 5ES 24/00513


The latest application to demolish two neighbouring detached houses on the un-made section of the Avenue, and construct a new residential development has been refused planning permission.

Two previous schemes, in 2018 and 2020, proposing a block of flats, were similarly refused.

The most recent proposal was for two blocks of four-storey adjoining townhouses - three units at the front of the site and four at the rear - with off-street car parking.

The reason for refusal was that it represented an unsatisfactory backland development, out of keeping with its surrounding area, and would have a detrimental impact on neighbouring No. 76c in terms of impact on outlook, noise and disturbance.

## 134 Worsley Bridge Road, Beckenham BR3 1RP 24/01572

An application to convert this detached Edwardian house, situated on the corner of Copers Cope Road, to a house of multiple occupation (HMO) has been refused permission.




Last year, planning permission was granted to enlarge the original house to form 5 bedrooms, with extensions to the side, rear and to the roofspace.

This latest application was for the subdivision of the three floors to provide 18 single-bed flats with access to a shared kitchen and dining room.







It was refused on the grounds that it would fail to provide a satisfactory standard of good quality accommodation for future occupiers due to the deficient size of the flats and a poor internal quality of accommodation; the development would result in an intensification of the site, which would harm the neighbouring residential area in terms of increased levels of noise and general disturbance; and it failed to make adequate provision for refuse storage for future occupiers.

#### Amended design for the former Beckenham Theatre site

As readers will recall a planning application went in for the development of the former Beckenham Theatre site was submitted to Bromley Council in Oct 2022. The application has been under consideration by the council for all that time. During the application process some design changes have been made, these include:

- Provision of on-site play space (32sqm) and omission of one parking spaces as a result
- New cycle store entrance direct from Manor Rd
- Increase in separation distance between the three-storey projecting element and the side boundary of 44 Bromley Rd, giving 6.5m separation to the building
- Addition of mansard roof on the first floor to appear more subservient and match the 2+ storey roof massing of the neighbouring buildings
- Red brick from top storey swapped to grey brick.


## 139 High Street, Beckenham BR3 1AG 22/02224

An application to enclose the open space in front of the old Lidl supermarket entrance on the High Street and create a new shop unit has been granted planning permission. Separate access will be provided for the adjacent serviced offices.



## 135-137 High Street, Beckenham BR3 1AG (ex-Lidl) 24/02405

An application for a lawful development certificate has been made to convert the old Lidl supermarket premises to a gym. The Gym Group, which has branches in Sydenham and Catford, is the proposed future occupier. It is a huge floor space for a gym.



## Land adjacent to 39 Southend Road, Beckenham BR3 1AG 23/04589

Following a public consultation exhibition last November, an outline planning application has been submitted to develop a vacant plot of land on the corner of Stumps Hill Lane, opposite Calverley Close.

The scheme is for a four-storey block of 26No one, two and three-bedroom flats and basement parking for 26 cars. Eight of the flats are proposed for social rented provision
