NEW POLICE PLATFORM FOR NEIGHBOURS

The Met Police have launched a new platform called Met Engage —a two-way communication tool designed to improve how they share information and gather evidence locally.

For example, if there's a car theft on a specific road the police can send an alert



directly to people in that area to warn them. At the same time, they can request any evidence — like sightings or doorbell footage — which neighbours can easily upload through the portal.

NEIGHBOURHOOD POLICING - GET INVOLVED

Beckenham has four Police Safer Neighbourhood teams with dedicated police officers for Kelsey & Eden Park, Clock House, Beckenham Town & Copers Cope, and Shortlands & Park Langley. To encourage community involvement with neighbourhood policing each SNT has regular Safer Neighbourhood Panel meetings hosted by a community chair and attended by the Police, Councillors and interested members of the public.

UPDATE FROM THE MAY COMMUNITY POLICE MEETING

On the evening of 1st May 2025, a Police Community meeting was held at the Orion Eden Park High School. This was the second such meeting, bringing together the four neighbouring SNP areas to enhance community

engagement, better understand concerns and collate local knowledge for more effective policing. As highlighted in the Spring 2025 Review, all residents were welcome and circa 80 attended.



An introduction to SNP procedures was

followed by a residents and Council Q&A session with a panel of senior police officers plus constituency MP, Mr Liam Conlon. A number of ward councillors also attended. Issues raised included: police resources,

shoplifting, violent crime, vehicle theft, child use of vapes, criminal targeting of vulnerable school children, increased school engagement with police, illegal use of electric scooters, public visibility of police patrols, protection of senior citizens against scams, criminals' tourism from other boroughs, park vandalism and perception that reporting crime has little effect.

The police representatives stressed the importance of reporting crime, especially at a time of limited resources and despite possible low outcome expectations. Reporting should be done by 999 in an emergency, by 101 or online at the Met police website (www.met.police.uk) for non-emergencies. The website reporting allows a "hot-spot" picture to be created, e.g. for anti-social behaviour, and for resources to then be specifically targeted. The street-safe website can be used in the absence of a specific crime but where the area is considered unsafe.

It is hoped that more residents will get involved by attending their relevant SNP meetings and that further Police Community meetings can be arranged to allow residents to directly question senior police management and government attitudes to policing.

PARKING CHARGES AT ELMERS END GREEN AND UPPER ELMERS END ROAD/ LINKS WAY

In our spring edition, we reported on increased parking charges in most car parks in Bromley and also on some shopping parades and other street parking. The car park charges came into effect in April. We understand that officers are consulting ward councillors on charges on shopping parades, but we have not been able to input to these consultations.

WBRA are very concerned about the effects on local shops at Elmers End Green and also on their customers. People pop into



the shops – newsagent, pharmacy, grocers, bakery – for just a few minutes. They are unlikely to pay for an hour's parking to do so. This will impact the

shops and also the customers themselves who will probably travel farther at more inconvenience and cause more pollution. At The Green, it is likely to mean people stopping along The Green side and dashing across the road, risking accidents. At Upper Elmers End Road and Links Way, the charges will mean more pressure for residents just outside these charging zones, many of whom do not have off-street parking places.

WBRA would like to contribute to the consultation on hours and days of operation and the minimum charging period (15 mins would be much better than an hour). A couple of free minutes would be most welcome. Will people be able to drop passengers off or will they be fined if they pull in for a few seconds? There seems to be a brisk turnover of vehicles at present. If people are charged for an hour when stopping for only a couple minutes, LBBromley will certainly meet its objective of raising a lot of money!

PROBLEMS WITH THE 358 BUS SERVICE

The 358 service from Crystal Palace to Orpington was one of the first routes to be made all electric. There have been problems with the route being cut short because of lack of charge.



We raised this with GLA member Tom Turrell. TfL's reply was

"The route 358 is the first route to be converted to opportunity charging electric which requires pantograph charging at each end of the route (overhead conductive charging). This

type of charging model allows buses to operate a longer route for a full service day, receiving a top up charge at Crystal Palace and Orpington bus stations. When converting any route to battery electric there is a reasonable adjustment period which we see with any new vehicles entering the fleet. Performance on the route continues to be monitored and will support learning about this technology trial as part of our zero-emission target for the bus fleet.

In mid-February a burst water main on Anerley Hill resulted in the curtailment of bus services, including the route 358. The new 358 buses were parked up at Elmers End as the alternative terminus whilst works commenced to fix the water main."

Tom Turrell has also raised issues concerning accessibility for wheelchair users on the 358.

Rotary Beckenham raises over £3,000 for Bromley Homeless

On Sunday 11 May, Rotary Beckenham staged the seventh Swimalong at The Spa in Beckenham, fundraising for this year's chosen charity, Bromley Homeless. The charity is the only charity in Bromley providing a holistic

The website has been undergoing extensive work recently, leading to long periods of unavailability. We hope this will be resolved soon.

Orion School Balmoral Avenue 16/03145



An application was made in March to extend the use of the football pitch and Multi Use Games Area (MUGA) for community use up to 9.30pm weekdays and 4.30pm at weekends. Previously the MUGA pitch did have such permission. Residents are extremely alarmed by the prospect of continuous use of these facilities right behind their garden fences. Noise and light pollution would be likely 7 days a week, whereas at present, use of the

football pitch is limited to school use.

Over 100 people live in close proximity to the pitches. Rear bedrooms are

likely to be used by children whose bedtimes are before the cut off times. There have been 120 objections to the proposal with 7 comments of support for increased community use of



facilities. Some of the latter do however indicate that demand for use of the facility would extend way beyond LB Bromley's borders. While, in principle, community use of school facilities is a good thing, WBRA has supported the residents in their objections, saying that when the school was granted permission in 2016, conditions were imposed to protect the residents from exactly this noise and light pollution. WBRA said it cannot be the case these residents are now of no importance.

186, 188 & 190 Bromley Road Beckenham BR3 6PG 24/00583

An appeal has been lodged by the developers against the Council's decision earlier this year to refuse planning permission for an application to demolish three neighbouring, detached houses on Bromley Road and replace them with a block of flats.

The three houses are situated on the corner of Ashmere Avenue, near to the Esso petrol station on the brow of the hill. The proposed development was for a four-storey block of 23 flats, with underground car park,

comprising 8 one-bed and 15 two-bed units providing homes for up to 66 people. The scheme included a basement car park, accessed from Ashmere Avenue. No affordable housing was provided in the development.

More than 200 local residents objected to the proposal.

Coleridge House, 79 and 79a Bromley Road, Beckenham BR3 5PA 20/03881/RECON

Further up Bromley Road, the Council has made a significant decision to refuse an application by the developer to carry out a number of amendments to the design of a £12M block of flats currently under construction and nearing completion

Situated in a prominent location at the brow of the hill between Beckenham and Shortlands, at the corner of Downsbridge Road, Coleridge House at 79 and 79a Bromley Road was once a distinctive building from the mid-180os and one of the last remaining grand villa houses that once

lined Bromley Road. In 2022. consent was granted for its demolition and a new, five-storey development of 27 flats, including an underground car park. At the time, more than 200 letters of objection to the development were made, Our Association.



Bromley Civic Society, The Victorian Society and many others also objected strongly to demolishing the previous building.

Changes to the original planning permission included external alterations to the elevations and roof, increase in basement footprint, a new structure in the garden to provide an air intake to the basement car park and changes to the internal layouts of the flats and alterations to the mix of units.


The Council refused the changes to the development, named Belle Vue House, on the grounds that the resultant design would result in an unsatisfactory internal living conditions for the future occupants by reason of outlook and vulnerability to noise; the siting, size and scale of the building, including roof addition/roof plant equipment, would appear excessive in size, incongruous in design and out of keeping with the scale and design of the original approved scheme and harmful to its setting in the streetscene; the proposed window and balconies at roof level would cause a loss of privacy to neighbouring properties and cause noise disturbance; the proposal has not demonstrated that it would provide the relevant obligations regarding affordable housing viability and net zero-carbon offsetting. Additionally, insufficient information had been submitted to demonstrate that the proposed development would achieve the highest standards of fire safety to ensure the safety of all building users.

Christ Church Halls, Fairfield Road, Beckenham BR3 3LE 25/00214

Permission was granted last month for the partial redevelopment of the Church halls site on Fairfield Rd and The High St, following a public consultation held in September last year. The image below shows an Artist's impression, as viewed from High St.



Three halls and interconnecting buildings, completed at different times, currently occupy the site: The Lea Wilson Hall, on the corner of the High St, built in 1877, the Main Hall on Fairfield Road completed in 1901 and the Jubilee Hall behind Village Car Care dating from 1926. All of the buildings sit within the Beckenham High St Conservation Area. None are listed, but the Main Hall is a locally listed structure. These piecemeal additions over the years, combined with the varying floor levels across the various buildings, mean that the complex no longer meets modern standards in terms of accessibility or fire safety.

The three halls will be retained and restored, and the Lea Wilson Hall is being altered, with the most significant changes being the insertion of an additional floor level, a new roof, and the lowering of existing window sills facing onto the pavements. The existing link buildings and road frontage between the Lea Wilson and Main Hall will be demolished and replaced with a new two-story building that incorporates a new fully accessible entrance to all three halls. The interior is also to be fully accessible and will include lifts to all the various levels and disabled toilets.

8-12 Bromley Road, Beckenham BR3 5JE 25/00564

Another application for the development of a small parcel of land behind the buildings adjacent to the Methodist Church has been refused.

The scheme involved the demolition of garages that currently occupy the land, and the construction of three very small houses.

Reasons for refusal were similar to the previous attempt, and included accommodation of inadequate size, amenity and outlook that would result in unsatisfactory accommodation for future occupants, along with access to the site for emergency services.

28 Manor Road Beckenham BR3 5LE 25/00461

An application for the conversion of one of the few remaining family houses on Manor Road to five flats has been refused planning permission. A one, two and three storey extension was also proposed at the rear.

The Council's reasons for refusal were that the height and scale of the scheme, as well as the proximity to the boundary and the proposed rear balconies, would have a detrimental effect on the adjacent properties. It would have an overdominant and intrusive visual impact, and noise and would result in disturbance associated with the use of the balconies and proposed rear extensions. The proposed development also provided an unsatisfactory layout and quality of accommodation for future occupiers.

Land adjacent to Flat 1 Beckenham Court, The Avenue 25/01541

An application has been made for the installation of a 17.5m high mobile phone pole and associated telecoms cabinets on the south side of The Avenue, close to the junction with Southend Rd.
